Uttarakhand Disaster & Accident Analysis Initiative (UDAAI) is a monthly initiative by Dehradun-based environmental action and advocacy group, Social Development for Communities (SDC) Foundation. The goal of the UDAAI reports is to document disasters and accidents in Uttarakhand, leading to human and ecological casualties. UDAAI is based on media reports in respectable publications in English and Hindi newspapers, as well as news portals. UDAAI neither attempts nor claims to document all disasters and all accidents in Uttarakhand; its focus instead is to document major casualties and non-casualty events on a regular basis.

We strongly believe that with the perils of inclement climate and unabated disasters, the ecologically fragile and earthquake-prone state of Uttarakhand needs to take many more steps to increase its disaster preparedness. We therefore see UDAAI as a document that highlights attention towards the urgent need of a holistic disaster management and accident minimization policy framework in Uttarakhand.

It is our earnest hope that UDAAI will spur political leadership, policy makers, bureaucracy, research and academic institutions, businesses, civil society organisations, media and the citizenry at large to initiate inclusive, regular and action-oriented conversations on the subjects of resilience, mitigation and adaptation in Uttarakhand. With mainstreaming and a greater focus on the issue, there is likely to be an improvement in the process of planning of climate actions and disaster management in Uttarakhand.

pass through tunnels. Once the digging of tunnels is complete, the track-laying process will most likely begin in June. Of the 16 bridges on the rail line, construction of four has been completed."

RNVL is executing the project with the help of nine project monitoring consultants (PMCs) from foreign countries including the US, Italy, Sweden and Turkey. Each PMC has been awarded one or more of the 10 civil construction packages which are being executed by big Indian companies including Max Infra, L&T, Hindustan Construction Company, Mega Engineering Infrastructure Ltd., Navyug and Rithwik, an official said. "The work allotted to these companies is almost similar and they are doing it simultaneously in different stretches," he added.

Shankar Singh Bisht, one of the active participants of the campaign against cutting down of trees, said, "People from the region gathered here to tie a holy thread to protect the trees which have been marked by the authorities for cutting. We will continue our campaign until the government gives up its decision to cut trees." "The instructions by CM Dhami are a temporary relief," he said.

Mukesh Chandra Bhatt, a priest of Jageshwar Dham, said ancient deodar trees are significant and have stood there for hundreds of years.

"They (deodar trees) are the identity of the temple and this place. They are linked to Jageshwar, which is derived from Nageshwar Daruka. 'Daruka' signifies God in Sanskrit. Some of the trees which have been marked to be cut down are sacred and have been standing in the region for hundreds of years." "We worship them as gods," he added.

Bhatt further said the government of the said the said the government of the said the government of the said the

Bhatt further said the government should explore alternatives instead of cutting the trees in such a large number.

Local community members on Monday also convened a meeting and gave a memorandum to sub-divisional magistrate (SDM) NS Naganyal over the matter.

Filmmaker Vinod Kapri said, "These Deodar trees are hundreds of years old. A deodar tree can grow only 5 to 7 inches a year, if it gets good sunlight. Imagine how long it would have

taken for deodar trees 150-200 feet tall. Now there is a plan to cut them in two-three months. The issue is not just about Uttarakhand, but the country. Many trees are worshipped and revered as gods. These deodars have played an important role in conservation of our environment, they can't be cut sudenly. It is a serious issue. Everybody should talk about it."

Dehradun-based social development for communities (SDC) foundation's Anoop Nautiyal, said,"I add my voice to the growing chorus of #SaveJageshwar campaign. What's at stake is more than cutting a 1.000 trees, it's akin to erasing the identity and belief system of the region. I urge concerned people to take steps to conserve, not cut trees. It is crucial that we stand up for the cause."

Jageshwar temple is an ancient and a famous temple around 35 km from Almora district headquarters. It is a group of 124 ancient temples dated between the seventh to fourteen centuries.

Dhrub Singh Martolia, division forest officer (DFO) of the area said, "The ancient Jageshwar temple has been included under Manaskhand Mandir Mala Mission. Under this mission, the temple is to be beautified and better connectivity has to be ensured. Widening of the road upto 3-km is part of the mission."

"The project is in its initial stage and trees which are to be axed for the proposed road are being identified. After this process, a proposal will be sent to the central government. Such projects which are related to forests take a lot of time. There is no sense making hue and cry at the initial stage," he added.

March 27, 2024 : Two panels to assess high-risk glacial lakes in Uttarakhand

The state government has established two expert teams to conduct a risk assessment of five potentially perilous glacial lakes in Uttarakhand. These lakes have been identified as high-risk and prone to glacial lake outburst floods (GLOFs). The aim is to mitigate potential dangers associated with these lakes.

The National Disaster Management Authority (NDMA), operating under the Union Ministry of Home Affairs, has identified 13 such glacial lakes in Uttarakhand, and have been categorised into three levels of danger – A, B, and C, with 'A' indicating the highest level of risk.

Secretary Disaster Management Department Ranjit Sinha said that the initial phase of assessment will focus on the five 'A' category lakes, which are primarily located in the Pithoragarh and Chamoli district. Sinha outlined the process, saying the survey will occur in two phases, with the first phase scheduled for May-June this year. Sinha added, "Subsequently, instrumentation, installation of early warning systems, and implementation of disaster mitigation measures will follow suit."

March 30, 2024 : Significant landslide in Silyaan village, a gaushala and five houses in danger

The danger of landslides has increased in Silyaan village following the process of Jaspur-Nirakot road cutting. Heavy rains resulted in a local gaushala hanging low, when the land on which it was standing gave away from a side. This has also threatened the existence of five houses in the vicinity.

The villagers have asked for immediate action from the authorities. The village pradhan Jitendra Gusain said that this has happened due to the lackadaisical attitude of the people from the Public Works Department (PWD) and he had informed the executive engineer.

He added that Neeraj Agarwal, Executive Engineer of PWD Bhatwari block paid a visit with his team after eight days. Agarwal assured the village people that proper nets will be put around the landslide area and safety works will be carried out soon.
